## Summary of Testing Methods and Key Findings

Equicare CS is a care coordination platform that enables provider staff to manage patient care (navigation and follow-up), and patients to view their health information online (via Patient Portal). At this time, the Certified Health IT Module is sold to the oncology care (ambulatory) setting. For this reason, the Real World Testing plan will apply to this care setting.

The Patient Portal contains certified functionality for patients to view, download, and transmit their care summary. As such – the criterion for § 170.315(e)(1) View, download, and transmit to 3<sup>rd</sup> party has been included for Real World Testing.

Equicare identified 6 customer sites to monitor usage of View, Download and Transmit over a duration of 11 months. The results indicate that patients were successful in viewing and downloading their care summary. Patients were also successful in transmitting their care summary – but this was based on a very small sample size due to low usage.

Real world testing was conducted in Oncology care (ambulatory) setting.
